In the event that Fourway has to retain an attorney that is not our salaried employee, to obtain possession of its property or to collect any monies owed under this contract; the customer agrees to pay the reasonable attorney fee charged by that attorney as well as any court costs. Fourway or its representatives are authorized to remove equipment provided upon termination of service. The replacement cost of the equipment is \$400.00 and will be owed if we are prevented from getting the equipment back and/or if the equipment has been damaged that isn't due to an act of God or Nature. In the event that a customer on the Fourway No Worry Plan decides to cancel it and has a large managed router, it will need to be returned within 14 business days or a no return fee will be applied to the customer's account. They can either drop the router off at our office or mail it in with a mailing service of their choice (office address is 12700 4A Road, Plymouth IN 46563). The no return fee for the large managed router is \$300.

In the event that a customer on the Fourway No Worry Plan with Whole Home WiFi System decides to cancel it, all of the nodes (routers) will need to be returned within 14 business days or a no return fee will be applied to the customer's account for each node. They can either drop the nodes (routers) off at our office or mail them in with a mailing service of their choice (office address is 12700 4A Road, Plymouth IN 46563). The no return fee for each node (router) is \$200.
